# कई सप्ताह से बंद है दो स्कूलों में मध्याह्न भोजन

कोलकाता, 24 मार्च |

देश में हर बच्चा स्कूल जाए और लगातार जाए, उसकी पढ़ाई अघर में ना छूटे, इस मकसद से सरकारी स्कूलों में मध्याह्न भोजन की योजना शुरू की गई थी। कालक्रम में इस पहल का असर भी देखने को मिला। अक्षर ज्ञान लेने के लिए स्कूल जाने वाले बच्चों की संख्या में काफी इजाफा देखा गया। यह बात अलग है कि कभी-कभार कम गुणवत्ता, कभी बासी और कभी ठंडा भोजन परोसने की शिकायत आती रही हैं, फिर भी यह योजना चालू रही और विद्यार्थी इसका लाभ उठाते रहे।






इस बीच, बंगाल के दो स्कूलों के विद्यार्थियों को वीते कई सप्ताह से मध्याह्न भोजन नहीं मिल रहा, जिसका कारण है बढ़ती महंगाई के बीच रसोइयों के वेतन में कटौती। ‘सेल्फ हेल्प ग्रुप’ के सदस्यों ने वाजिब वेतन की मांग को लेकर मध्याह्न भोजन बनाना बंद कर दिया है, जिसका असर बच्चों की पढ़ाई और स्वास्थ्य के साथ-साथ देश के भविष्य पर पड़ रहा है। मध्याह्न भोजन के प्रभारी समूह के सदस्यों ने वेतन कटौती के विरोध में बांकुड़ा जिले के दो स्कूलों का घेराव कर विरोध जताया। जिले के लालबाजार इलाका स्थित नामो बागदीपाड़ा इंद्र प्राथमिक विद्यालय और लालबाजार प्राथमिक विद्यालय के छात्र मध्याह्न भोजन से वंचित हैं। सुत्रों के मुताबिक कभी इन दोनों स्कूलों में विद्यार्थियों की संख्या 60 से ऊपर हुआ करती थी। इतने सारे छात्रों के लिए मध्याह्न भोजन पकाने के लिए प्रति स्कूल
